CHYBA administration developed the initial draft of the plan after consulting with various stakeholder groups and the school needs previously identified through our annual LCAP process and the development of the Expanded Learning Opportunities (ELO) Grant Plan. It was discussed at the September and October board meeting to elicit input and feedback from the CHYBA Board of Directors, staff, students, and public attendees at that meeting. It was also shared digitally with CHYBA stakeholders, including all staff, families, community partners and with the student Youth Policy Committee (YPC), with an option to provide feedback via a survey link. The feedback from the initial board meeting, the stakeholder meetings, and survey responses were taken into consideration for revisions to the final plan. CHYBA evaluated its stakeholder engagement opportunities and determined that (Civil Rights Groups/ Tribes/ Advocates) are neither present nor served by the LEA. The final plan was discussed and voted on at the public meeting on October 22, 2021.

A description of how the development of the plan was influenced by community input.

Our community's key priorities for re-opening schools included a focus on social-emotional health and wellness, engagement and interactions, education, mental health and safety. There are special considerations to be addressed regarding air ventilation and providing outdoor learning and eating areas for students and staff, in addition to expanded and frequent cleaning and sanitization.

Learning Continuity and Attendance Plan:

In-Person Safety Protocols and Diagnosing Learning Loss: Additional staff to keep class sizes at a ratio under 1:10 staff:student ratio and provide adequate classroom supports such as additional time for instructional aides and other support staff to support students through academic progress monitoring and Personalized Learning Plans. Ensure two-way communications and provide time for staff to make phone calls to students and families on a regular basis.

Supporting Learning Continuity: Weekly support sessions for teachers, flexible staff roles and responsibilities to ensure expanded classroom and campus coverage, regular check-ins and targeted support for foster youth and pupils experiencing homelessness. Expand extended day/year program capacity and offer transportation and support services.

Learning Loss Strategies and Measuring Effectiveness: Use of screener assessments to evaluate student learning status, use of RtI/PLC and MTSS protocols to address areas of pupil learning loss, analyze and identify learning gaps related to access, opportunity and/or achievement among student groups, use of ELD checklist, and use of additional staff supports for tutoring and mitigation services to students, particularly special education students.

Student Well-Being: Provide mental health services and social-emotional learning curriculum and related services, to include targeted small groups and individualized support provided by added hours to mental health and behavioral specialist staff. Conduct home visits, provide parenting series, and expanded services via the Family Resource Center, to include helping parents access online services and information.

Stakeholders are very interested in having young people still be able to attend school onsite. Due to numerous quarantine situations it is recommended that CHYBA also establish an Independent Study program. CHYBA has completed the task of implementing an Independent Study program in full compliance with all mandates. Stakeholders, staff, and board members felt strongly that Independent Study would be a necessity to keep students making progress when they had to be out of school due to COVID quarantine. Administrative staff also fulfilled all necessary requirements to become a rapid testing site and support staff were trained to administer the tests. In this way, more students could continue to stay on campus if they met all guidelines including the period testing required. Staff members had input to suggest more students should be taking advantage of the 8-9 a.m. 'Response to Intervention' (RtI Time) that would allow for even more personalized assistance for students. Stakeholders were also in favor of summer school that involved both CTE, electives, and academic activities.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before October 29, 2021 and must be submitted for review and approval within five days of adoption. A school district must submit its ESSER III Expenditure Plan to its COE for review and approval; a COE must submit its plan to the California Department of Education for review and approval. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - **Tier 4 – Demonstrates a Rationale:** practices that have a well-defined logic model or theory of action, are supported by research, and have some effort underway by a State Educational Agency, LEA, or outside research organization to determine their effectiveness.

 - Providing mental health services and supports, including through the implementation of evidence-based full-service community schools;
 - Planning and implementing activities related to summer learning and supplemental after school programs, including providing classroom instruction or online learning during the summer months and addressing the needs of underserved students;

- Addressing learning loss among students, including underserved students, by:
 - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;

- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
